India Trade Promotion Organization (ITPO), in exercise of powers conferred on it vide Customs Notification No.3 dated 9.1.1989 as amended by Notification No.66 dated 16.3.1995, is pleased to approve the holding of the above event subject to the following:

- (a) Products covered: (i) Consumables like wine, food, cosmetics etc.
(ii) Garments, Household items, software, automotive components, electronic appliances, agrifood processing equipment & energy related equipment

Please note : (a) For all CONSUMABLES APPLICABLE DUTIES HAVE TO BE PAID.
(b) Capital equipment, machinery etc. may be permitted under ATA Carnet.

- (b) Overseas Participation from : France.

(c) The approval is issued to your organization and not to any individual person or participant in your exhibition. The facility of duty free temporary import will be available only to foreign exhibitors/participants, who have confirmed their participation in the above exhibition by remitting participation fee in foreign exchange. Temporary import will be allowed under ATA Carnet System only. In this connection, Ministry of Finance (Department of Revenue) Notifications No.157/90-Cus, 14/90-(NT)-Cus, No.158/90-Cus. all dated 28.3.90, as amended from time to time and Central Board of Excise and Customs circular No.55-CBEC dated 3.8.1998, etc. refer.



- (d) The exhibition will be open to general public or to a particular section of the general public for which it has relevance; and will be in public interest.
- (e) The goods will be re-exported within a period of six months from the date of import or any other period, as may be stipulated by the Customs Authorities in India.
- (f) Parties/exhibitors whose intention is to sell or dispose of exhibits in India should not avail the facility of duty-free import of exhibits facility extended through this letter.
- (g) Participation charges from all foreign participants should be collected in foreign currency. Temporary importation may be facilitated only to those exhibitors who pay participation charges in foreign exchange.
- (h) The approval is in no way indicative of sponsorship or support of the event by ITPO and any projection of such indication by the organizers by using the name or logo of ITPO would render withdrawal/cancellation of this letter.
- (i) ITPO reserves the right to withdraw/cancel the approval at any time without assigning any reason.
- (j) A copy of the report of the event with one copy of fair catalogue/exhibitors list should be submitted to ITPO within one month of the conclusion of the event.
